YOU'LL GET DOUBLY SOAKED GOING TO SOCORRO

Mexico has raised entry fees for all marine parks, effectively doubling them. The Socorro Park fee is now 3,622 pesos per day, about \$178, meaning the typical six day liveaboard trip will cost about \$1070 in park fees. Add to that high customs fees, sometimes several hundred dollars, and random divers getting charged for photographic equipment when they enter Mexico through Los Cabo Airport, and Socorro may be unaffordable for some divers. There may be some exceptions and discounts for the elderly, teachers, and students if CONANP approves documentation submitted in advance.
