## ***Proposed Amendment to Bylaws ARTICLE IV, Section 5***

**The words in red with underline are to be added to Section 5.**

### ARTICLE IV

**Section 5. No member shall hold more than one (1) office at any time, or serve more than four (4) consecutive terms in the same office.**

- Eliminates the restriction on the number of terms a member can serve on the board
- Increases the number of terms a member can serve in the same office from 2 terms to 4
